- The Group's gross profit margin was approximately 15.6% for the three months ended 31 March 2021 and approximately 16.0% for the three months ended 31 March 2020.
- Loss for the period for the three months ended 31 March 2021 amounted to approximately HK\$0.4 million and approximately HK\$1.5 million for the three months ended 31 March 2020.
- Basic loss per share for the three months ended 31 March 2020 and 2021 were approximately 0.19 HK cents and 0.05 HK cents respectively.

Note i: Amount represents statutory reserve of the subsidiaries in the People's Republic of China (the "PRC"). NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

1. GENERAL

Vertical International Holdings Limited (the "Company") is a public limited company incorporated in the Cayman Islands and its shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The immediate and ultimate holding company of the Company is Vertical Technology Investment Limited ("Vertical Investment"), a company incorporated in the British Virgin Islands. Its ultimate controlling party is Mr. Boon Ho Yin Henry, who is also the Chairman and Chief Executive Officer of the Company.

The addresses of the registered office and the principal place of business of the Company are Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands and Unit 2212, 22/F, Global Gateway Tower, 63 Wing Hong Street, Cheung Sha Wan, Hong Kong respectively. The Company is an investment holding company. The Company and its subsidiaries (collectively referred to as the "Group") are principally engaged in the manufacturing and trading of aluminum electrolytic capacitors and trading of electronic components.

The functional currency of the Company is Hong Kong dollars ("HK\$").

2. BASIS OF PREPARATION

This unaudited condensed consolidated financial statements for the three months ended 31 March 2021 (the "Financial Statements") have been prepared in accordance with Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants and the disclosure requirements of the Companies Ordinance (Cap.622 of the Laws of Hong Kong). Besides, the Financial Statements include applicable disclosures required by the GEM Listing Rules. The Financial Statements have been prepared under the historical cost convention and are presented in Hong Kong dollars and all values are rounded to the nearest thousand except when otherwise indicated.

The preparation of the Financial Statements requires the Company's management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of income and expenses. Actual results may differ from these estimates.

In preparing the Financial Statements, the significant judgements made by the Company's management in applying the Group's accounting policies and the key sources of estimation uncertainty are the same as those that applied to the Group's audited consolidated financial statements for the year ended 31 December 2020.

The Financial Statements have not been audited by the Company's auditor, but have been reviewed by the audit committee of the Company.

3. REVENUE

Revenue represents revenue arising on sales of manufactured aluminum electrolytic capacitors and trading of electronic components for the three months ended 31 March 2021.

No diluted loss per share was presented as there were no dilutive potential ordinary shares in issue for both periods.

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS REVIEW

The Group is engaged in the manufacturing and trading of aluminum electrolytic capacitors and trading of electronic components, including semiconductor devices and passive components.

The prolonged outbreak of the coronavirus disease 2019 (COVID-19) continues to bring uncertainties to the market. The business environment remains difficult and challenging.

For three months ended 31 March 2021, the revenue of the Group increased by approximately 58.7% to approximately HK\$25.5 million from approximately HK\$16.1 million for the three months ended 31 March 2020. The gross profit of the Group increased by approximately 54.7% to approximately HK\$4.0 million for the three months ended 31 March 2021 from approximately HK\$2.6 million for the three months ended 31 March 2020.

Despite short-term pressure on customer's demand due to the overall declining economy, the Group's ability to provide a cost-effective and more flexible supply chain and shorten the production cycle is helping it to build up more long-lasting customer relationships in the medium term which remains the key to the Group's growth momentum. Revenue from sales of the Group's self-manufactured aluminum electrolytic capacitor, increased substantially from approximately HK\$12.7 million for the three months ended 31 March 2020 to approximately HK\$20.4 million for the three months ended 31 March 2021.

PROSPECTS

Given the dynamic circumstances and uncertainties of the COVID-19 situation, global economic growth may further slow down. Although this may pose a new challenge to the Group's business, the Group remains committed to investing in technology development, advancing its technology capabilities and enforcing the competitive advantage, which will help the Group achieve its long-term strategic and financial goals.

The current economic uncertainty is expected to continue. To cope with the challenging business environment, the Group will continuously review its business approach.

FINANCIAL REVIEW

Revenue

The Group's revenue increased to approximately HK\$25.5 million for the three months ended 31 March 2021 from approximately HK\$16.1 million for the corresponding period in 2020, representing an increase of approximately 58.7%. Such increase in the Group's revenue was mainly attributable to the Group's aggressive pricing strategy to increase its market share in order to neutralize the impact of global economic uncertainty.

The revenue for the sales of manufactured aluminum electrolytic capacitors increased by approximately 60.9%, from approximately HK\$12.7 million for the three months ended 31 March 2020 to approximately HK\$20.4 million for the three months ended 31 March 2021. The revenue derived from sales of trading electronic components increased to approximately HK\$5.1 million for the three months ended 31 March 2021 from approximately HK\$3.4 million for the three months ended 31 March 2020.

Cost of sales

The Group's cost of sales primarily consists of cost of goods sold and other direct costs. The cost of sales increased to approximately HK\$21.5 million for the three months ended 31 March 2021 from approximately HK\$13.5 million for the three months ended 31 March 2020, representing an increase of approximately 59.5%. The Group's cost of sales increased along with the growth in revenue for the three months ended 31 March 2021.

Gross profit and gross profit margin

The Group's gross profit increased to approximately HK\$4.0 million for the three months ended 31 March 2021 from approximately HK\$2.6 million for the three months ended 31 March 2020, representing an increase of approximately 54.7%. The Group's gross profit margin remained steady at approximately 15.6% for the three months ended 31 March 2021 and approximately 16.0% for the three months ended 31 March 2020.

Selling and distribution costs

The Group's selling and distribution costs increased to approximately HK\$1.0 million for the three months ended 31 March 2021 from approximately HK\$0.7 million for the three months ended 31 March 2020, representing an increase of approximately HK\$0.3 million. This increase was mainly due to increase in sales commission paid.

Administrative expenses

Administrative expenses primarily consist of employee benefit expenses, office supplies, depreciation of property, plant and equipment, legal and professional fees and other miscellaneous, general and administrative expenses. Administrative expenses decreased to approximately HK\$3.4 million for the three months ended 31 March 2021 from approximately HK\$3.6 million for the three months ended 31 March 2020, representing a decrease of approximately HK\$0.2 million. Such decrease was mainly due to the decrease in professional fee.

Income tax expense

Income tax expenses increased by approximately HK\$0.2 million, from approximately HK\$0.1 million for the three months ended 31 March 2020 to approximately HK\$0.3 million for the three months ended 31 March 2021.

Loss for the period

As a result of the cumulative factors discussed above, the Group recorded a loss for the period of approximately HK\$0.4 million for the three months ended 31 March 2021, as compared with the loss for the period for the three months ended 31 March 2020 of approximately HK\$1.5 million, representing a reduced loss of approximately HK\$1.1 million.

Basic loss per share

The basic loss per share for the three months ended 31 March 2021 was approximately 0.05 HK cents, whereas basic loss per share for the three months ended 31 March 2020 was approximately 0.19 HK cents, representing a decrease of approximately 0.14 HK cents.

RESERVES

Movements in the reserves of the Group for the three months ended 31 March 2021 are set out above in the unaudited condensed consolidated statement of changes in equity.

DIVIDEND

No dividend was paid, proposed or declared for the ordinary shareholders of the Company for the three months ended 31 March 2021 (for the three months ended 31 March 2020: HK\$Nil).

CAPITAL COMMITMENTS

As at 31 March 2021, the Group did not have any significant capital commitments (31 March 2020: HK\$Nil).

MATERIAL ACQUISITIONS OR DISPOSALS

The Group did not have any material acquisition or disposal during the three months ended 31 March 2021.

CONTINGENT LIABILITIES

The Group did not have material contingent liabilities as at 31 March 2021 and 2020.

Mr. Boon is the Chairman and the Chief Executive Officer of the Company and is responsible for the Group's major decision-making, overall strategic planning, determining corporate policies and daily operation and management of the Group. In the view that Mr. Boon is one of the founders of the Group and he has been operating and managing the Group since its establishment, the Board believes that it is in the best interest of the Group to have Mr. Boon taking up both roles for effective management and business development of the Group. Therefore, the Directors consider that the deviation from the code provision A.2.1 of the CG Code is appropriate in such circumstance.

The Company will periodically review and improve its corporate governance practices with reference to the latest development of corporate governance.

PURCHASE, SALE OR REDEMPTION OF THE COMPANY'S LISTED SECURITIES

Neither the Company nor any of its subsidiaries has purchased, sold or redeemed any of the Company's listed securities during the three months ended 31 March 2021.

AUDIT COMMITTEE

The Company established an audit committee ("Audit Committee") with written terms of reference in compliance with Rule 5.28 of the GEM Listing Rules and code provision C.3.3 of the CG Code. The Audit Committee consists of three independent non-executive Directors, namely Mr. Wong Wai Leung, Mr. Liu Kwan and Mr. Chik Kin Man Paul. Mr. Wong Wai Leung possesses the appropriate professional accounting qualifications and related financial management expertise as required in Rule 5.05(2) of the GEM Listing Rules, and he serves as the chairman of the Audit Committee.

The primary duties of the Audit Committee are to assist the Board in providing an independent review of the effectiveness of the Group's internal audit function, financial reporting process, internal control and risk management systems, and to oversee the audit process. The Audit Committee had reviewed the unaudited quarterly results of the Company for the three months ended 31 March 2021.
